The Chamber estimates that 5% of your membership dues investment is allocated to lobbying expenditures, and therefore under federal law 5% of your dues are not deductible as a business expense. Dues are non-refundable. Businesses, not individuals, are Chamber sember's principal representative carries that member's voting power and may be elected to serve as an officer or a member of the Executive Committee or Board of Directors. A member's associate representatives, although not having that member's voting or office holding privileges, may serve and vote at the Committee level. Chamber publications will commonly list principal and associate representatives.
